
SUBJECT:

STRICT COMPLIANCE OF THE PREVIOUS DECISIONS TAKEN BY BAR COUNCIL , IMPLEMENTATION OF WELFARE SCHEMES IN TRUE SENCE , IMPLEMENTATION OF AFDVOCATES PROTECTION ACT, EFFORTS FOR MAKING AMENDMENT/ REDUCTION OF STAMP VALUE , WHICH HAS BEEN HIGHLY ENHANCED BY STATE , FOR THE WELFARE OF LITIGANTS

Respected All,

With due respect to All the Elected Members of the Jharkhand State Bar Council , I would like to once again like to consider my requests which was previously also made by me in the meetings and also through written mails.

I raised a issue with regards to Enhancement of Stipends for the newly joined members and virtually we discussed and even agreed to enhance the same but till date the same has not been enhanced and meager amount of Rs 1000 is being paid which is very low in my opinion , I would request it to be enhanced to at least Rs 5000 per month , I request each and every member to support the cause and get it enhanced by passing the same through general body meeting , the resolution of passing the same be strictly complied with and the junior lawyers should be given financial assistance so that they can survive in profession . The other most important scheme of ours regarding payment of pension and family pension is also not taken care of properly , I have raised an issue that the widow of the deceased lawyers are given family pension for only three years after the death of deceased lawyer , it was decided in the general body meeting that the family pension amount will be given to the dependent widow till her death , and the entire amount which has not been paid after closure will be calculated and the

entire amount will be given in her account, but in spite of the said decision till date the same has not been started which is really painful , I have come across several widows of deceased lawyers who are unable to even get medical help due to financial crises, I once again raise this issue and request bar council to start the same and make payment of the entire dues along with interest in their account.

My proposal is that the pension amount which was discussed to be enhanced and till date no concrete decision has been taken, the pension amount be increased from Rs 7000/- to Rs 15000. government has also assured that the amount which will be paid by Bar Council on account of pension equal amount will be paid by state, in this manner if Bar council pays Rs 15000 same amount ie Rs 15000 will be paid by government, that means amount of Rs 30000(thirty thousand) will be received by advocates, though government has already taken decision but no amount is being paid by government, bar council should take immediate steps for implementation of the said government decision. So that the old age senior colleagues of ours who opt to take retirement may lead a peaceful dignified life not depending on others.

The much awaited Advocates protection act which is dream of all of us has not been enacted , we need to seriously pursue on the same and anyhow get it enacted for the safety of lawyers and his family members, Bar council has even drafted the act and sent it to the government for enactment, Bar Council Member have even meet the Hon'ble Governor And Hon'ble Chief Minister , We Have Even Received Assurance But Unfortunately We Could Not get it done request each and every member to kindly take the issue very seriously and during our tenure get the same enacted and passed by assembly.

government has enhanced huge amount of stamp in each heads by making amendment in the stamp act, bar council even took the issue and raised it, PIL is also pending before the high court, request u all to kindly get it expedited and some relief be given to the poor litigants as due to enhancement of court fee we lawyers practice is also being effected as very few civil litigations are being filled these days due to huge enhancement of court fee.


